#### 12/302- Matters arising

**Showman's guild** – Situation ongoing. Clerk will write to request date in August next year to conform with the charter.

**Drain behind Village Hall** –Cllr G Pursey will report to OCC. Carried forward.

**Town Hall Lift** – Clerk holds the papers for the insurance. The invoice will be put forward for payment at this meeting.

**OCC's offer of salt** – Clerk could not formally accept the salt offer as no definite place of delivery was supplied. The salt will be delivered to The Old School Community Centre, Clerk will complete the paper work. Cllr G Pursey has investigated bins for the storage.

**Weald Housing Site** – Cllr J Allinson emailed Mr Stuart Lillie, acting on behalf of the Colville Foundation to inform him that BPC had no objections to the scheme for social housing. Cllr R Norman will speak to WODC.

**Library** – Cllr J Allinson informed BLEST that she would be the contact for Bampton Library, now Miss M Quarterman had resigned. Cllr H Rainey expressed a wish to be involved with BLEST. It was resolved to delegate to Cllr H Rainey.

**Donkey Derby** – The SPAJER's successfully used The Old School Community Centre toilets for their Donkey Derby on August Bank Holiday.

**Mr P Lewis Contract** – Cllr D Turner advised Clerk that he had not received Mr Lewis's contract yet. Clerk to send through again. Mr Glenn Wright would like a job description of Mr Wheldon.

**WOA** – It was found that WOA had been using the Council Chamber without first booking it through Clerk. Clerk has been in touch with committee members of WOA and advised that they must first book to ensure that it is not being used by others. The key held by WOA has now been collected by Clerk.

**DoI** – Cllr's G Gascoigne, Dowding and Rainey to complete their Declarations of Interest.

**Rosemary Lane** – It has been noted that the foliage is overhanging from the property of Box House. Mr G Pursey will write to the owners to request that it is cut back from the highway.
